#### TO PULL OR NOT TO PULL

#### Course Description:

Advancements in delivering periapical surgery have resulted in success rates that can be equivalent to implant replacement when certain guidelines are adhered to. Periapical surgery as an adjunct to endodontic treatment is a proven approach. With the introduction of new surgical techniques and a systematic method to the diagnosis and treatment of compromised teeth, the clinician should be able to more accurately determine the long term prognosis for these treatment options. Evaluate treatment options with an evidence-based approach when a tooth is ailing or failing. This course will describe the indications and contraindications for performing or referring a patient for apical surgery. With a specific 7 step workup, including a correct history, radiographic and clinical evaluation, the decision to perform an apicoectomy will be weighed against further evaluation, a re treatment option, or extraction and replacement with an implant (immediate or delayed). As a result, a decision is more accurately made as to whether an implant or a fixed bridge (fixed partial prosthesis), a removable prosthesis (fixed or transitional temporary prosthesis), or other options would be the final treatment plan discussed with the patient.

#### **STATE GOVERNANCE & RULEMAKING 101**

#### **Course Description:**

This session provides an introduction and overview of the North Dakota State Board of Dental Examiners (Board)—the state governmental entity charged with the responsibility of regulating the practice of dentistry. Included will be a discussion of Board members, appointments and terms of office, laws that govern the dental profession, and the Board's roles, duties, obligations, and limitations. Specific attention will be paid to the complaints and disciplinary process, the Board's rulemaking responsibilities, and the Board's recent experience asking the Legislative Administrative Rules Committee to adopt changes to some of the regulatory laws that apply to dentistry.

#### Learning Outcomes:

Attendees will gain an understanding of the Board's:

- Relationship with and oversight by the Office of the Governor and State Legislative Assembly.
- Duties, roles, responsibilities, obligations, and limitations.
- Relationships with and differences between the Board and other governmental and non-governmental entities.
- Regulation of the practice of dentistry and licensees, with a focus on the applicable statutes, rules, regulations, and policies.
- Complaint and disciplinary processes.
- Rulemaking, including the overall process and the roles of the Board, its licensees, stakeholders, and the Legislative Assembly.
- Recent rulemaking efforts, including a discussion of possible decisions made by the Legislative Administrative Rules Committee at its September 4, 2024, meeting and the Board's proposed modifications to ND Admin Code chapter 20.

# ACTIONS & ALGORITHMS FOR MEDICAL EMERGENCIES: HOW TO SAVE A LIFE (INCLUDING YOUR OWN) (6 CE's) • Presented by: Dr. Daniel Pompa • 8:15 a.m. - 4:45 p.m.

#### **Course Description:**

There are more medically compromised patients coming to our offices than ever before. Acquire "up to the minute" actions for dealing with a medical emergency while challenging preconceived or outdated ideas. Daniel Pompa, DDS - Oral and Maxillofacial Surgeon, ADA Consultant and Seminar Series Speaker - discusses the prevention, preparation, recognition and management of medical emergencies. Delivered in an interactive, high energy, multi-media presentation frequently described by attendees as "highly informative," "engaging," and "exceptional." A step-by-step medical approach using basic physical diagnostic methods is reviewed, giving the attendee a clear understanding of these medical findings.

We will explore the "Conversational History" and how it will uncover medical issues not revealed by the standard health history form. Additionally, the participant will learn simple, non-invasive critical tests that can reduce overall risks. We clearly delineate indications for emergency drug use and proper dosages, as well as demonstrate how to assemble and maintain an ideal emergency drug kit. The newest techniques for drug administration will be shown for participants to hone their skills utilizing simulation models and real drugs. Dr. Pompa may incorporate live demonstrations to enhance the learning experience depending on the venue format.

- Discover three simple chair-side, non-invasive tests to help avoid an emergency.
- Recognize the most frequent life threatening emergencies and know when and why they occur.
- Review a systematic approach to treat the most common life-threatening scenarios.


